

Our combined cover allows you to include a number of insurances under one policy:

Combined insurance

This covers your property and liability risks and caters for typical union activities, including retail outlets, nightclubs, clubs and societies, volunteering, and fundraising events. It can also cover large summer balls and water-based or high-risk outdoor activities, such as surfing or climbing.

Motor insurance

It can be difficult to find cover for student drivers, which is why our motor insurance scheme caters for minibuses and other vehicles driven by students. Both fleet and non-fleet risks can be insured under the scheme. Breakdown cover is included as standard.

Temporary additional vehicles

Our online portal allows you to insure temporary hire vehicles in just two easy steps. This enables last-minute hires to be covered, including those starting during evenings and weekends, 365 days a year.

Directors' & Officers' Liability insurance

Financial protection for trustees, directors, and officers in students' unions, including defamation and employment practices cover.

Student Personal Accident insurance

Protection for students participating in organised sport and other activities, covering both the college or university and the student in case of injury. It pays out generous cash benefits to the injured student, with three levels to choose from:

- Basic – designed for non-sporting activities; offers protection at a low cost per head
- Essential – covers students involved in sport at a non-professional level
- Elite – offers extra benefits, including cover for broken bones and physiotherapy sessions

Small craft insurance

Our small craft scheme is designed for all types of clubs involved in water-based activities.
