It is hereby understood and agreed that:-

In respect of Section A Personal Accident:-

a) The Insured Persons are noted as follows:-

Category 1) All Sports and Operational Committee Members and/or Member of the Board of Trustees of the Insured Age Limit: Under 85 years at the Policy Effective Date

Category 4) All Volunteers at competitions organised by PCHQ Age Limit: Under 85 years at the Policy Effective Date

b) In respect of Category 1 and 4 only, cover in respect of any Insured Persons aged 75 years to 84 years is amended to read as follows:

Section A: Personal Accident Items 1-5 - GBP 50,000 Item 6(a) - GBP 12,500 Item 6(b) - GBP 50,000 Item 7 - GBP 50,000 Item 8 - Not covered Section B: Illness Not Covered

c) The following definitions are noted and agreed: -

Out of Pocket Expenses:

M. Stol

Additional costs unexpectedly and necessarily incurred by an Insured Person solely as a result of the Bodily Injury for reasonable food, drink, telephone calls and transportation costs.

Temporary Total Disablement - For persons in paid in employment:

Disablement which is medically determined to temporarily prevent an Insured Person from undertaking all parts of their usual occupation as carried out at the date of the Accident.

Temporary Total Disablement - For persons who are not in paid employment:

Disablement which is medically determined to temporarily prevent an Insured Person from undertaking their usual duties or activities (including attending to scholastic duties) as carried out at the date of the Accident and resulting in Out of Pocket Expenses.
