

**PDPA Statement for
MediReach**

For the Purposes of this Personal Data Protection Policy, 'MediReach' shall include:

1. Participating Insurers of Howden MediReach;
2. Howden Insurance Brokers Pte Ltd in its capacity as an insurance intermediary (as defined in Insurance Act 1966); and
3. MHC Asia Group Pte. Ltd., MHC Medical Network Pte. Ltd. and their related corporations and affiliates (collectively, "HMI Managed Healthcare") who are supporting Howden Insurance Brokers Pte Ltd in connection with Howden MediReach,

(collectively, "MediReach", "us", or "we").

We take our responsibilities under Singapore's Personal Data Protection Act 2012 (the "PDPA") seriously. In order for us to enroll you (and where applicable, your dependants) into, and process your (and where applicable, your dependant's) medical insurance claims under your employer's directed medical insurance programme, we will necessarily need to collect, use, disclose and/or process your (and where applicable, your dependant's) personal data or personal information.

Such personal data includes information set out in this Statement and any other personal information provided by you or possessed by us.

"personal data" means data, whether true or not, about an employee and/or the employee's dependant(s), who can be identified: (a) from that data; or (b) from that data and other information to which we have or are likely to have access.

The personal data which we may collect in respect to your employer's directed medical insurance includes, without limitation, your (and where applicable, your dependant's):

- a) name or alias,
- b) gender,
- c) NRIC/FIN or passport number,
- d) date of birth,
- e) nationality, and country and city of birth;
- f) mailing address, telephone numbers, email address and other
- g) contact details;
- h) bank account details;
- i) medical records

Such personal data may be collected, used, disclosed and/or processed by us for the Purpose(s) of:

1. your accessing MediReach's mobile apps and online platform
2. maintaining your (and where applicable, your dependant's) medical insurance claims records;
3. carrying out your instructions or responding to any enquiries by you;
4. processing, handling and/or dealing with your (and where applicable, your dependant's) medical insurance claims including but not limited to the settlement of such claims and any necessary investigations relating to the claims under your employer's directed medical insurance policy/policies, and enforcing our contractual and/or legal rights;
5. complying with applicable law in administering, processing, handling and/or dealing with your (and where applicable, your dependant's) medical insurance claims; and
6. purposes which are reasonably related to the foregoing.

We may/will also be collecting from sources other than yourself, personal data about you (and where applicable, your dependant(s)), for one or more of the above Purposes, and thereafter using, disclosing and/or processing such personal data for one or more of the above Purposes.
